US Forest Service Main Line extension- Martha Williams approached the Board about extending the water main to the Forest Service building they are currently located outside the town limits. The US Forest service will pay all the cost for the extensions. With some discussion it was decided to turn over the request to Planning Commission to discuss annexation of the property into the limits of town.

Christy Doon-Department of Local Affairs- Respond on the DN Coop sale of property. It was mentioned what we had thought if the Town wanted to sell the property we would of be in breach of the grant contract. The sale would have to be the amount of the grant plus more, and it would have to be returned to DOLA.
