a. Del Norte Public Library Annual report-Glynnis Williams and Sue Williams were present at the meeting and gave the DN Library annual report and library budget for 2024. The library has been remarkably busy. They offer summer reading programs, book sales during Covered Wagon Days, and they do offer the library for community events. Sue mentioned that the adventure book walk that is in the Town Park seems to be enjoyed by those who are in the park, and they do change out the book, about every couple of months, for a new story book. To sponsor the book walk, it is \$250.00. With some discussion, Trustee Shelly Burnett made a motion to give the Del Norte Library \$250.00 to sponsor adventure book story in town park, seconded by Trustee Brenton Williams. ROLL CALL: Lobato, Williams, Muncy, Burnett, Trujillo, Velasquez and Asplin. All with aye vote. Mayor Trujillo declared the motion passed.

RESOLUTIONS

Discussion on Rio Grande County IGA Marketing Tourism Funds- Rio Grande County Commissioners had sent over the IGA Marketing funds agreement, the funds are distributed to Del Norte Chamber of Commerce for events and marketing efforts for the Town. A motion was made by Trustee Shelly Burnett to approve the IGA submitted by Rio Grande County, seconded by Trustee Louie Velasquez. Roll call: Trustee Lobato, Williams, Mayor Pro-Tem Muncy, Trustee Burnett, Mayor Trujillo, Trustee Asplin, and Trustee Velasquez. Roll call: All ayes, Mayor declared motion carried.

CONTRACTS/AGREEMENTS/LEASES

1. Rio Grande Hospital easement and agreement of relocating current water line-this was tabled last month, the agreement was revised that if the Town were to put in the line, it would be at the expense of the hospital and not the Town. A motion was made by Trustee Leigh Anne Lobato to approve the agreement between the Town and Valley Citizens' Foundation for Health Care, Inc., seconded by Trustee Brenton Williams. STAFF PROPOSALS, TOWN ATTORNEY/DN CHAMBER REPORTS, AND ACTIONS

Will Kreutzer- Del Norte Chamber presented the Town with a check for \$15K. This is from the MOU that the Town and Chamber had on the Downtown Improvement project. He is stepping down after 12 years of Chamber president. The Town Board thanked Will for the contribution to Del Note Chamber of Commerce and the Downtown Improvement project.

Discussion on Mettje Swift storefront removal of wood awning - Town Administrator Martinez stated the reason she put this on the agenda is for discussion is that the wood awning is in the way of the installation of the new sidewalks that will be going in this summer. She talked with Mettje and she wanted to know what the Town was going to put in its place, I let her know we have no intentions of putting the awning back up and across the sidewalk. If she wanted an awning it would be attached to her building. With more discussion, Public Works, Kevin Larimore stated that his crew will go over to see how it is attached to see if they can remove it. All items along the State right-away will have to be removed before we do the contractors walk through when we go out to bid on this project.

Municipal Courts-Attorney Farish mentioned to the Town Board that with the recent municipal court cases he suggested that the Town Board consider going to a court of record. Discussion was held and the motion was made by Trustee Leigh Anne Lobato and seconded by Brenton Williams to have municipal courts a court of records. Roll call: Trustee Lobato, Williams, Burnett, Trustee Asplin, and Trustee Velasquez. All Yes. Mayor Pro-tem Muncy and Mayor Trujillo; Voting No Mayor declared motion carried. Attorney Farish will construct an ordinance for next month's board meeting.

1041 Regulations-Town Attorney Farish did mention that 1041 regulations that SLV COG has been working on he has voiced his concerns that if an application were to come to the Town for water outside the SLV, it could be a burden on staff and the cost could be very substantial. He has proposed a statement of what he would like in the regulations to help the municipalities that he represents.
