

**Del Norte Town Board**  
**Special Board Meeting, March 6, 2024**

The Board of Trustees of the Town of Del Norte, Rio Grande County, State of Colorado, met in special board meeting on March 6, 2024, in the Board Meeting Room, 140 Spruce Street, Del Norte, Colorado at the hour of 6:00 p.m. **The Town Board** met in a Special session for the discussion of determining to pursue a petition for certiorari to the Colorado Supreme Court on the Anzalone case.

**Martha Williamson** was present and thanked staff for the information that she requested, but wanted to let the Town Board know before they have a discussion that they consider the fiscal impact on the Town if it goes forward.

**Ramona Dordan** –thanked the Town Board for standing with the employees on the environment of harassment that they were going through, and it was not an easy decision to do what they did but the impact could have been larger if the employees were not protected.

**Pat Thompson**- a local resident, fire district board member, and physician also wanted to let the Town Board know that the discussion to move forward was going to impact the Town financially especially knowing the Town was going to have to some cost to the Town sewer and water system. The Town Board thanked the public for the comments.
